Upcoming Equalities Work

When we contact you to ask for equalities information, please be assured that any responses you provide will be anonymous. However, if there are any specific equalities related issues that you want to raise with us so that we

can adjust how we provide our services to you (eg information in a specific format), we will ask you to provide your details and give us permission to hold the information, so that we can respond to your request. Any information that you do choose to provide will be processed only by Lister staff, and will be held securely, and treated in the strictest confidence.
